

CSK Top 100 Spenders Offer Terms and Conditions

Last updated on 5th August 2022.

These terms and conditions as updated from time to time apply and regulate the Benefit (*defined hereinafter*) available to Top 100 customers holding the Credit Card (*defined hereinafter*).

I. Definitions:

In these terms and conditions, unless there is anything repugnant to the subject or context thereof, the expressions listed below, if applicable, shall have the following meanings:

- a. **"Benefit"** means Meet and Greet session with selected players.
- b. **"CSK"** shall mean Chennai Super Kings, a franchise cricket team.
- c. **"Cardholder/s"** means the individuals to whom the Credit Card (defined hereinafter) has been issued by ICICI Bank Limited (**"ICICI Bank"**).
- d. **"Credit Card"** means the Chennai Super Kings ICICI Bank Credit Card.
- e. **"Benefit Period"** means the period from 20th Aug'22 - 20th Dec'22.

II. Terms of the Offer:

1. This Benefit shall be available to the first 100 Top spenders during the Benefit Period provided the Cardholder/s conducts a spend of a minimum of Rs. 200,000 during the Benefit Period subject always to ICICI Bank's discretion.
2. The following transactions will not be considered as valid transactions for the purpose of the Benefit:
 - i. Cancelled transactions,
 - ii. Cash withdrawals at Automated Teller Machine ("ATM") or ICICI Bank branches,
 - iii. Void transactions,
 - iv. Tax payments,
 - v. Mutual fund purchases
 - vi. Wallet transactions or any transactions done for commercial or business purposes and
 - vii. Any other transactions in respect of any fee/charge that may be levied by ICICI Bank from time to time.
3. The Meet and Greet will be non transferrable i.e. no other family member or friend can avail the Benefit in place of the Cardholder/s.
4. Delinquent Cardholder/s shall not be eligible for this Benefit .

5. If a person ceases to be a Cardholder/s, at any time during the Benefit Period, the Benefit shall lapse and such Cardholder shall no longer be eligible for the Benefit .

Notwithstanding anything contained to the contrary in any of the terms and conditions applicable to the Credit Card, the Cardholder/s are only eligible to avail this Benefit , or any other similar benefit, once in a financial year (1st April – 31st March of the succeeding year), irrespective of whether this Benefit or any other benefit providing similar privileges is available on any other card issued by ICICI Bank to the Cardholder/s.
