

## Terms and Conditions for iBizz Killer Promo

These terms and conditions (“Terms”) apply to and regulate the “iBizz Killer Promo”

### 1. Definitions

In these Terms, which expression shall include all amendments and modifications made thereto from time to time, the following words and phrases have the meaning set below unless the context indicates otherwise:

**“Accounts”** for the purpose of this Offer shall mean retail Current Accounts with ICICI Bank Limited (“ICICI Bank”) of all constitutions including individuals, proprietors, partnerships, private limited companies, public limited companies and others.
