

Terms and conditions

These Terms and Conditions (the “Terms”) apply to and are in addition to and not in derogation of the Terms and Conditions of ICICI Bank’s Savings Accounts (the “Primary Terms and Conditions”) as available on www.icicibank.com. To the extent of any inconsistency between these Terms and the Primary Terms and Conditions, these Terms shall prevail. All capitalized terms used herein but not defined shall have the same meaning as specified under the Primary Terms and Conditions.

DEFINITIONS

- **“Alliance Partner”** shall mean respective partner who has entered into an alliance agreement with ICICI Bank Limited (“ICICI Bank”) for purpose of providing the Offer.
- **“Customer/s”** for the purpose of this Offer shall mean, a person who holds Savings Account (as defined hereunder), has email id registered with ICICI Bank, and performs a debit transaction* in his/ her Savings Account, through internet banking and / or debit card during the offer period subject to such terms and conditions as shall be specified by ICICI Bank from time to time.
