

Terms and Conditions for “Lee Cooper” Bag for Eazypay Mobile App merchants on opting for Aadhaar Pay as collection mode:

Last updated Date: 23rd August’17

I. Definitions

1. "**Alliance Partner**" shall mean Nexans India Pvt Limited, which has entered into an alliance agreement with ICICI Bank Limited ("ICICI Bank") for purpose of providing various offers.
2. "**Customers**" shall mean and include all the merchants registered in Eazypay Mobile App.
3. "**Offer**" shall mean “Lee- Cooper” bag provided by the Alliance Partner to merchants registered on Eazypay mobile app and opted for Aadhaar Pay as a collection mode during 1st September 2017 to 30th September 2017 both days inclusive.
4. "**Offer Period**" shall mean the period commencing from 1st September 2017 till 30th September 2017 both days inclusive.
5. "**Primary Terms and Conditions**" shall mean the terms and conditions applicable to ICICI Bank’s Eazypay Mobile App facility/service.

2. The Offer is valid for first 6000 (Six thousand) Customers only i.e. the first 6000 (Six thousand) Eazypay Mobile app registered customers who opt for “Aadhaar Pay” as a collection mode in the Offer Period.

1. On login into the Eazypay Mobile app, Customer will be prompt for “Additional collection mode”. Customer needs to select “Aadhaar pay” in the option.
2. A dialog box will open asking the Customer to confirm a debit of Rs. 2600 from their account, this is the payment towards a biometric scanner that ICICI Bank will provide to the Customer for finger print scan

3. After successful debit bank will dispatch a biometric scanner to the Customer's registered address along with "Lee Cooper Bag" in 15 working days.

IV. The availability of the Offer is based on the following criteria

1. This Offer cannot be clubbed with any other Offer that may be made available to the ICICI Bank by the Alliance Partner.
2. The Offer is non-transferable, non-binding and non-encashable.
3. Only one Offer is allowed per account.
