

# બારેજામાં મકાનમાં ગેસ-સિલિન્ડર બ્લાસ્ટથી ઈજા પામેલામાંથી સારવાર દરમિયાન વધુ એકનું મોત, કુલ મૃત્યુઆંક ૮ થયો

(પ્રતિનિધિ) અમદાવાદ, તા. ૨૪ અમદાવાદ બિજ્જાના દસકોઈ તાલુકાના બારેજા- મહિજડા રોડ પર પતરાંના મકાનમાં ગેસ-સિલિન્ડર બ્લાસ્ટ થતાં એક જ પરિવારનાં સાત લોકોનાં મોત થયાં હતાં. મંગળવારે રાતે બનેલી ઘટનામાં ગુરુવારે સારવાર દરમિયાન ત્રણ શુક્રવારે ચાર અને આજે સવારે વધુ એક મહિલા સીમાબાઈ અહીંરવાર (ઉં. વ. ૨૫)નું સારવાર દરમિયાન મોત થતાં કુલ મૃત્યુઆંક ૮ પર પહોંચ્યો છે. ઘટનાનો ભોગ બનેલા મધ્યપ્રદેશના પરિવારમાં શોક ફેલાયો છે.

રહેવાસી પરિવાર પતરાંના મકાન બનાવીને રહેતા હતા. મંગળવારે રાતે પરિવારના મકાનમાં ગેસ-સિલિન્ડર ચાલુ રહેતાં લીકેજ થયું હતું. પાડોશમાં રહેતા પરિવારને ગંધ આવતાં તેમણે દરવાજો ખખડાવ્યો હતો અને એમાં ઘરમાંથી લાઈટ ચાલુ કરતાં જ મોટો બ્લાસ્ટ થયો હતો. ઘરમાં સૂતાં જ બાળકો સહિત ૧૦ લોકોને ગંભીર ઈજા થઈ હતી. ઘરનાં પતરાં ઊડી ગયાં હતાં. બંધો સામાન ઘરની બહાર ઊડીને પડ્યો હતો. તમામને સારવાર માટે હોસ્પિટલમાં ખસેડવામાં આવ્યા હતા. ઘટનાને પગલે અસલાલી પોલીસ પણ ઘટનાસ્થળે પહોંચી હતી. સારવાર દરમિયાન ૭ લોકોનાં આ ઘટનામાં મોત થયાં હતાં. મૃતકોમાં રામચારી બાઈ અહીંરવાર (ઉં. વ. ૫૬), રાજુબાઈ અહીંરવાર (ઉં. વ. ૩૧), સોનુ અહીંરવાર (ઉં. વ. ૨૧), વૈશાલી બેન અહીંરવાર (ઉં. વ. ૭), નિતેશ બાઈ અહીંરવાર (ઉં. વ. ૬),

પાયલ બેન અહીંરવાર (ઉં. વ. ૪), આકાશ બાઈ અહીંરવાર (ઉં. વ. ૨)નો સમાવેશ થાય છે અને આજે અસારવા સિવિલ હોસ્પિટલમાં વધુ એક મહિલા સીમાબાઈ અહીંરવાર (ઉં. વ. ૨૫)નું મોત થયું હતું. તમામ શ્રમજીવી મધ્યપ્રદેશથી રોજરોટી અર્થે ગુજરાતમાં આવ્યા હતા. અહીં ફેક્ટરીમાં કામ કરતા હતા. ઘટનાની બાજુ થતાં કેન્દ્ર સરકારના તાજેતરમાં જ કેબિનેટ પ્રધાન બનેલા જયોતિરાદિત્ય સિંધિયા અને મધ્યપ્રદેશના મુખ્યપ્રધાને આ મામલે ટ્રીટ કરી દુ:ખ વ્યક્ત કર્યું હતું. મધ્યપ્રદેશનાં મુખ્યપ્રધાને રાહતની બહેરાત કરતા મૃતકોને ૪ લાખ બચ્ચારે બાળકોનાં પરિવારને ૨ લાખ આપવાની બહેરાત કરી હતી. બચ્ચારે ઈબ્રાહમ તમામની સારવાર મફત કરવાની બહેરાત કરી હતી. આ દરમિયાન સ્થાનિક પોલીસે એકએસએલની મદદથી આ સમગ્ર ઘટનાની તપાસ શરૂ કરી છે.

(પ્રતિનિધિ) અમદાવાદ, તા. ૨૪ કેરોનાની બીજી લહેર દરમિયાન રેમ્ડેસિવિર ઈન્જેક્શનના કાળાબજારના કેસમાં ભૂટ્ટાની ચાર વ્યક્તિઓની પાસા લેઈળ અટકાયતને પડકારવાના કેસમાં ગુજરાત હાઈકોર્ટે રાજ્ય સરકારને તીખા સવાલો કર્યાં હતા. હાઈકોર્ટના જસ્ટિસ પરેશ ઉપાધ્યાયે સરકારને ટકેર કરી હતી કે, પરિવાર માટે બેરેમ્ડેસિવિર ઈન્જેક્શન લઈ જતા સામાન માણસને પકડીને તેની સામે પાસા લગાવી દેવામાં આવે છે તો પાંચ હજાર ઈન્જેક્શન લઈને બીજા શહેરમાં વહેંચી દેનાર રાજકીય પાર્ટીના સિનિયર નેતા વિશે સરકાર પાસે શું ખુલાસો છે? તેનો જવાબ નાગરિક પુરુષ વિભાગ આપશે કે સરકાર? શું આ બાબતને પણ બહારદેશની અરજી સાથે બેટી દેશે? બહાર માટે ઈન્જેક્શન લઈ જનાર સામે પાસા કેવી રીતે કરે? તેને બેટમાં નાખવાનો? અને ૧ હજાર ઈન્જેક્શન વેચનારને હાર-તોણ? ભૂટ્ટાની ચાર વ્યક્તિની રેમ્ડેસિવિર ઈન્જેક્શનના

કાળાબજારના કેસમાં પાસા લેઈળ ધરપકડ કરી હતી. અહીં નોંધવું ઘટે કે, હાઈકોર્ટમાં ભૂટ્ટાના ડિરેક્ટ એગેન્ટ્સે ચાર વ્યક્તિ સામે પ્રિવેન્શન ઓફ એક્ટિવિટી એન્ડ મેઈન્ટેનન્સ ઓફ સપ્લાય ઓફ એક્સિસિવિલ ડ્રોગ્સ એક્ટ લેઈળ પાસા લગાવીને ધરપકડ કર્યાં, ચાલે પાસાનો ગુનો રદ કરવા અરજી કરી છે. જેની સુનાવણી દરમિયાન હાઈકોર્ટે સરકારની

અટકાવી કાઢી હતી. હાઈકોર્ટે આખરી નિશ્ચલ આવે નહીં ત્યાં સુધી ભૂટ્ટાના ચારે જણ સામે પાસાનો હુકમ રદ કરવાનો આદેશ પણ કર્યો હતો. મહત્વનું છે કે, કેરોનાના ધન્ય વેરિએન્ટ અણધાર્યાં હોવાથી ત્રીજી લહેર અચાનક ત્રાટકી આકાંટ ઉભી ન કરે તે માટે લોકો અને સરકાર બંને સાવધાન રહેવા અને ટેકરીની રાખવા ગુજરાત હાઈકોર્ટે સૂચન કર્યું છે.

**Notes:**

1. During FY2021, the Covid-19 pandemic resulted in a nation-wide lockdown in April-May 2020 which substantially impacted economic activity. For the banking sector, these developments resulted in lower demand for loans and fee-based services and regulatory measures like moratorium on payment of dues and standstill in asset classification to mitigate the economic consequences on borrowers. It also resulted in increase in provisioning reflecting higher actual and expected additions to non-performing loans. The easing of lockdown measures subsequently led to gradual improvement in economic activity and progress towards normalcy from the second half of FY2021.

The second wave of the Covid-19 pandemic in April-May 2021 led to the re-imposition of localised/regional lock-down measures in various parts of the country. In the absence of regulatory dispensations like moratorium on loan repayments and standstill on asset classification, the impact on the quality of the loan portfolio would likely be sharper and earlier during fiscal 2022. The second wave has started to subside from June 2021 onwards and there has been a gradual lifting of lock downs, resulting in an increase in economic activity.

The Bank made net Covid-19 related provision of ₹ 4,750.00 crore in FY2021 and held an aggregate Covid-19 related provision of ₹ 7,475.00 crore at March 31, 2021. During Q1-2022, the Bank wrote-back Covid-19 related provision of ₹ 1,050.00 crore based on the updated position of various portfolios underlying these provisions (made Covid-19 related provision of ₹ 5,550.00 crore in Q1-2021) and accordingly held Covid-19 related provision of ₹ 6,425.00 crore at June 30, 2021.

The impact, including with respect to credit quality and provisions of the Covid-19 pandemic on the Bank and the Group, is uncertain and will depend on the trajectory of the pandemic, progress and effectiveness of the vaccination programme, the effectiveness of current and future steps taken by the government and central bank to mitigate the economic impact, steps taken by the Bank and the Group and the time it takes for economic activities to return to pre-pandemic levels.

2. In Q1-2022, the Bank has changed its provisioning policy on non-performing advances to make it more conservative. The aforementioned change resulted in higher provisions on non-performing advances amounting to ₹ 1,127.15 crore in Q1-2022.

3. During Q1-2021, the Bank sold equity shares in its subsidiaries and made a net gain of ₹ 3,036.29 crore in standalone financial results and ₹ 2,715.87 crore in consolidated financial results (during FY2021: net gain ₹ 3,669.94 crore in standalone financial results and ₹ 3,297.05 crore in consolidated financial results).

4. During Q1-2022, the Bank has allotted 9,044,970 equity shares of ₹ 2 each pursuant to exercise of employee stock options.

5. The Indian Accounting Standards (Ind AS) are currently not applicable to banks in India.
