Power plants meet record 201GW need

Demand Comes Amid Coal Crisis And Heat Wave

New Delhi: India's power plants met maximum demand of over 201 GW (gigawatts) at 2.51pm on Tuesday, beating the previous record of over 200 GW clocked on July 7 last year, as the economy began firing on all cylinders and a raging heatwave further fuelled consumption.

Coming amid low fuel inventories at coal-fired plants, the meeting of higher peak explains the faster depletion of inventories at generation units and underlines the chinks in transportation.

Heat forces Odisha colleges to close

A fter schools, the Odisha government has now suspended classes in higher education institutes from Wednesday till May 2 in the wake of heatwave conditions. reports Minati Singha. On Tuesday, Boudh recorded a maximum day temperature of 44.5 degrees Celsius, the highest of the season so far, followed by 43.8° at Balangir and 43.6° at Sonepur.

Transmission lines trip, Mumbai sees 3rd mega outage in 2 years

Mumbai: The transmission gridfailure of the 400 KV Kalwa-Padgha line, the third such incident in two years, once again led to power outages in several parts of the Mumbai Metropolitan Region on Tuesday morning.

Areas affected included parts of the island city, the eastern and western suburbs, Thane, Navi Mumbai, Kalyan and Dombivli. Power cuts lasted up to 80 minutes amid the sweltering summer heat. The load loss across MMR was around 2,300 MW, an official from Mahatransco said. In many buildings, lifts and water pumps became non-operational during the outage.

The previous two outages had occurred in October 2020 and February 2022. Experts say it's high time for strengthening the transmission network by adding more lines. Tuesday's outage came at a time Maharashtra is reeling under power deficit of 2,500 MW.

The outage on Tuesday began at 10.15am. By 11.35am, supply was restored at all places. A Mahatransco official said, "A fault occurred at the Padgha substation, due to which 400KV lines Kalwa-Padgha 1 and 2 feeding to Mumbai tripped". The tripping resulted in tripping of Tata Power's Dharavi substation which supplies power to Mumbai.


