- a. Enter details in GSTN site and select 'Over the Counter' as mode of payment.
- b. Post selecting ICICI Bank and clicking on generate challan, you will be able to download the challan.
- c. Post downloading the challan, you need to visit ICICI Bank branch for payment of the challan.
- Alongwith challan, submit the cheque/ cash/ DD at the branch. On submission, the branch official will provide the payment receipt. (Screenshots of Challan with Cheque/Cash/DD are given below)
