a)	ICICI Bank in its capacity as debenture trustee (DT) has received sale proceeds of assets of Machinery Manufacturing Corporation Ltd. (In liquidation) from Official Liquidator, Bombay High Court against an undertaking to bring back the same as & when directed by the Court. To protect the interest of debenture holders & in view of the pending undertaking the amount has been invested in Fixed Deposit.
b)	The disbursement will be made of (i) Rs. 245.80 per debenture in respect of 13.5% NCD of Rs. 150/- each & (ii) Rs. 80.40 per debenture in respect of 15% NCD of Rs.100/- each, after adjusting the fees and expenses incurred by ICICI Bank Ltd. as debenture trustee (DT).
