# TERMS AND CONDITIONS

### I. DEFINITIONS

- "Alliance Partner" or "Goibibo" shall mean iBibo Group Pvt Ltd, who has entered into an alliance agreement with ICICI Bank for purpose of providing the Offer *(defined below)*.
- "Customer(s)" for the purpose of this Offer *(defined below)* shall mean an authorized holder of a valid MINE credit card issued by ICICI Bank.
