## <u>Process note for claim of Unclaimed deposits / Inoperative accounts</u>

As per RBI circular - RBI/2011-12/389 DBOD.No.Leg.BC. 81 /09.07.005/2011-12 February 7, 2012 the list of unclaimed deposits / inoperative accounts which are inactive / inoperative for ten years or more has been displayed on Bank's website. The list so displayed will contain only names of account holders(s) and his/her address in respect of unclaimed deposits / inoperative accounts.

#### Search of records:

- Claimant can search the record(s) based on below criteria -
  - Name and Date of birth
  - Name and PAN
  - Name and Passport number
  - Name and Pincode
  - Name and Telephone number
- · Search can be done only based on primary holder's details
- If match is found, the name and addresse(s) of deposit holder will be displayed

#### Claim Process:

### I) Claim by self-

 Customer can visit the nearest branch and submit the Unclaimed Deposits claim form (As per annexure 1 below) duly filled and signed, along with valid Identity proof document.

#### II) Claim by legal heir / nominee -

- For claim process, legal heir can visit the nearest branch and submit the Unclaimed Deposits claim form (As per annexure 1 below) duly filled and signed, along with following documents.
  - Valid Identity proof of the claimant
  - Copy of death Certificate
- For detailed process, the policy for claim settlement of deceased and missing persons may be referred on the website.

### III) Claim by non-individuals -

 For claim of non-individual accounts, please submit the Claim form on Company's letter head duly signed by authorised signatories along with valid identity proof.
