The total amount of foreign exchange purchased from or remitted through all the sources in India (including from Debit Card) during the financial year shall be within the overall limit of the Liberalised Remittance Scheme (LRS) prescribed by the Reserve Bank of India for Resident Individuals (i.e., currently USD 250,000). In case the remittances are made beyond the permissible limit under LRS, ICICI Bank is authorised to take appropriate action, which includes blocking the card for international transactions, repatriation of the excess funds etc.
