# Terms and Conditions governing Forex Offer on Outward Remittances and Forex Prepaid Card

These terms and conditions apply to and regulate the forex Offer on outward remittance and Forex prepaid cards offered by ICICI Bank Limited.

## **Preferential Rate Offer on Foreign Exchange Services**

#### I. Definitions:-

- 1. "Foreign Exchange Services" shall mean forex availed by Customer in the form of Outward Remittance & "Forex Prepaid Card". Outward remittance is availed online through Money to World(M2W) platform on "ICICI Bank Internet Banking" and offline through any of the ICICI Bank Forex enabled branch, while Forex Prepaid Card is availed online through "iMobile app" and "ICICI Bank Internet Banking", and offline through any of the ICICI Bank Forex enabled branch. Outward Remittance is available both online and offline for ICICI Bank existing customer and non-customer, however Forex Prepaid Card/Reload is available both online and offline for ICICI Bank existing customer, which is valid and subsisting during the Offer Period (defined hereinafter).
- 2. "Customer/s" shall mean a customer of ICICI Bank (existing & new customers), to whom the Offer has been granted by virtue of such customer purchasing forex for the specified currencies during the offer period. Customer/s shall not be presently working for ICICI Bank & group companies.
- 3. "Forex rate"/"Transaction rate"/"Conversion rate" is an exchange rate (also known as a foreign-exchange rate) between two currencies. It is the rate at which one currency will be exchanged for another. It is also regarded as the value of one country's currency in terms of another currency.
- 4. "Day" shall mean a period of 24 hours, starting from 12.00.00 A.M. and ending at 11.59.59 P.M. according to Indian Standard Time (IST) during the Offer Period.
- 5. "Offer" shall be defined as additional services or benefits provided by ICICI Bank, in association with third party/alliance partners.
- 6. "Eligible Customer" means all ICICI Bank customers and non-customers who are doing outward remittances and/or all ICICI Bank customers who are re-loading Forex Prepaid Card under all purposes in foreign currencies as applicable during the Offer Period. Offer is applicable for following foreign currencies: USD, GBP, EUR, AUD, CAD, CHF, SGD, NZD.
- 7. "Offer Period" shall mean the period commencing from January 01, 2022 to February 28, 2022, both days inclusive.
- 8. "Preferential Rate" Offer shall mean discount of 30 paisa per unit on applicable foreign currency as mentioned above.
  - Preferential Rate Offer is presented to Eligible Customer on multiple transaction during the Offer Period.
- 9. "Purpose of Forex" is defined as purpose under which customer travels &/or sends funds abroad as in consonance with Foreign Exchange Management Act, 1999 (FEMA) guidelines.
- 10. "Promo Code" is a code which needs to be entered by customer while doing online outward remittance transaction through Money2World(M2W) platform on Retail Internet Banking(RIB) and/or Forex Prepaid Card re-load transaction through iMobile and RIB. Customer needs to enter Promo Code as applicable for the product during

the offer period. For offline transaction, customer will be assisted by branch/Forex Relationship Manager (Forex RM).

#### II. Offer Details

- 1. The Offer is valid for ICICI Bank Customer/s only and shall be valid and subsisting during the Offer Period, unless otherwise notified by ICICI Bank.

- 3. Select the option 'Overseas Transfer'
- 4. Click on 'Send Money Now', a new page of Money2World would open
- 5. On the right side under 'Quick Links', click on "Add Receiver" and then click on submit
- 6. Add the receiver details like name, address, country, etc.
- 7. Please verify the receiver details added through One Time Password (OTP) received on registered mobile number
- 8. Post addition of receiver, please click on "Transfer money" tab and then initiate the transaction by mentioning the purpose of remittance, amount, currency, etc.
- 9. Enter Promo Code- "STDY30" to avail 30 paisa/unit discount on transaction rate
- 10. Please verify the transaction details and then complete by entering the OTP received on registered mobile number and the debit card grid value.

## b. Through internet banking (Non-ICICI Bank Customer/s)

#### Registration steps:

Select the relevant option:

- i. Aadhaar has a verified mobile number (Online E-KYC)
- ii. Aadhaar does not have a verified mobile number (Physical visit to branch)
  - a) For 'Aadhaar has a verified mobile number', below are the steps:

Step 1: Enter Aadhaar number & verify using the OTP received on registered mobile number

Step 2: The basic details will be displayed. Enter the Permanent Account Number (PAN), e-mail ID and other profile details as required

Step 3: Enter password and captcha

Step 4: Read and confirm the applicable terms and conditions and the declaration

Step 5: Click on video KYC, an officer of the ICICI Bank will authenticate the Customer, take a live photo, signature and a PAN card photo

Step 6: Bank will verify the request. Once approved, Customer/s will be able to transact up to USD 25,000 per financial year.

- b) For: 'Aadhaar does not have verified mobile number', below are the steps:
- Step 1: Enter the basic registration details like name, address, PAN number, etc
- Step 2: Enter password and captcha
- Step 3: Read and confirm the applicable terms & conditions and the declaration
- Step 4: A registration number will be generated and Customer/s will have to visit the branch for completing the registration process & submit the KYC documents such as PAN card and any address proof passport, voter ID Card, driving license, etc.

Step 5: Upon KYC verification at the branch, click 'Validate Registration' on the Money2World homepage

Step 6: Enter OTP sent to mobile number and e-mail ID to complete registration.

#### Steps to Initiate the transfer on Money2World:

- Post successful registration on Money2World, login to Money2World with the user ID (registered email id) and password
- 2. Add the Indian bank account from where funds are to be sent
- Click on "Add Receiver" and enter the receiver details like receiver name, address, receiver bank details like account number, bank name, branch address, SWIFT code, routing number (for USA), IBAN (for European countries), BSB code (for Australia), transit number (for Canada), correspondent bank details (for cross-currency transfers) etc.
- 4. Enter the other transaction details like currency, amount, purpose of remittance

- 9. Click on 'Generate card' (The card will be delivered in 5 working days).

- 2. Click on 'Cards & Loans' under the 'My Accounts' section
- 3. Click on 'Forex & Prepaid Cards' under the 'Cards & Loans' section
- 4. Click on 'View and Manage your Forex Prepaid Card'
- 5. Click on 'Reload'
- 6. Select "Purpose of Travel", enter "Passport number", "Passport expiry date", "Country of visit", "Travel Date" & "Return Date"
- 7. Fill amount in respective currency for Forex Prepaid Card product.
- 8. Enter promo code as- "STUDY30" to avail 30 paisa/unit discount on transaction rate
- 9. Enter grid card for authorization & complete payment.

## iii. If users' existing forex prepaid card is not linked online

- 1. Login at internet banking account at <a href="www.icicibank.com">www.icicibank.com</a>
- 2. Click on 'Forex & Prepaid Card' under the 'My Accounts' section
- 3. Click on 'Link Forex Prepaid Card'
- 4. Enter the requisite details
- 5. Click on submit
- 6. A SR is generated and the TAT for linking of the travel card to the savings account is 1 working day.

#### iv. Post users' existing forex prepaid card is linked online

- 1. Login at internet banking account at www.icicibank.com
- 2. Click on 'Forex & Prepaid Card' under the 'My Accounts' section
- 3. Click on 'Reload' tab
- 4. Select "Purpose of Travel", "Country of visit", "Travel Date" & "Return Date"
- 5. Fill amount in respective currency for Forex Prepaid Card product.
- 6. Enter promo code as- "STUDY30" to avail 30 paisa/unit discount on transaction rate
- 7. Enter grid card for authorization & complete payment
- 8. Forex Prepaid Card will be re-loaded instantly on best effort basis. In case of any system issues, card will be reloaded within 24 working hours of initiating request.

## b. Through i-Mobile

## i. For New Forex Prepaid Card users (existing Customer of ICICI Bank)

- 1. Login at ICICI Bank iMobile application
- 2. Click on "Cards & Forex" section

- 3. Click on "Forex Prepaid Cards"
- 4. Select "Purpose of Travel", enter "Passport number", "Passport expiry date", "Country of visit", "Travel Date" & "Return Date"
- 5. Fill amount in respective currency for Forex Prepaid Card product.
- 6. Enter promo code as- "STUDY30" to avail 30 paisa/unit discount on transaction rate
- 7. Enter grid card for authorization & complete payment
- 8. The travel card will be delivered in 2 working days. Forex Prepaid card will be re-loaded in one working day after receipt of document at the branch.

#### ii. If users' existing forex prepaid card is not linked online

- 1. Login at ICICI Bank iMobile application
- 2. Click on "Cards & Forex" section
- 3. Click on "Forex Prepaid Cards"
- 4. Click on "Link your Forex Prepaid Card Now"
- 5. Enter the requisite details like Forex Prepaid Card number & passport number
- 6. Click on validate & submit
- 7. An SR is generated and the TAT for linking of the Forex Prepaid Card to the savings account is 1 working day

## iii. Post users' existing forex prepaid card is linked online

- 1. Login at ICICI Bank iMobile application
- 2. Click on "Cards & Forex" section
- 3. Click on "Forex Prepaid Cards"
- 4. Click on desired linked Forex Prepaid Card number for reload
- 5. Click on "Reload"
- 6. Select "Purpose of Travel", "Country of visit", "Travel Date" & "Return Date"
- 7. Fill amount in respective currency for Forex Prepaid Card product.
- 8. Enter promo code as- "STUDY30" to avail 30 paisa/unit discount on transaction rate
- 9. Enter grid card for authorization & complete payment
- Forex Prepaid Card will be re-loaded instantly on best effort basis. In case
  of any system issues, card will be reloaded within 24 working hours of
  initiating request.

# Terms and Conditions governing Promo code offer provided by ICICI Bank Foreign Exchange Services

Internet Banking and/or iMobile channels as applicable and offline through forex enabled branches as applicable.

- 2. "Transaction" refers to outward remittance transaction and/or Forex Prepaid Card re-load transaction made by the Participants via internet banking and/or iMobile as applicable and/or ICICI Bank forex enabled branches as applicable.
