India on cusp of making it to bio-economy big league: PM

'8x Growth In Last 8 Years To \$80Bn, Number Of Investors Up 9 Times'

New Delhi: Prime Minister Narendra Modi on Thursday said that India's bio-economy has "grown eight times in the last eight years from \$10 billion to \$80 billion" and that the country is "not too far from reaching the league of top-10 countries in biotech's global ecosystem".

Speaking after inaugurating the Biotech Startup Expo 2022 at Pragati Maidan here, the PM hailed the contributions of the Biotechnology Industry Research Assistance Council (BIRAC) in the development of the sector, saying "BIRAC has played a big role in the new leap of new India". The exhibition was organised by the department of biotechnology to celebrate 10 years of BIRAC and showcase 75 successful startups supported by the agency.

The PM said the number of investors in the sector has risen nine times and funding for them have increased by seven

times. The number of biotech from six in 2014 to 75 now. "Biotech products have increased from 10 products to more than 700 today", Modi informed.

The PM said the government believes in strengthening every sector for giving momentum to the country's development, asserting that it has changed the earlier approach of focusing on a few sectors while ignoring others.

"In the last eight years, the number of startups in our country has increased from a few hundreds to 70,000. These 70,000 startups cover about 60 different industries. Of these, more than 5,000 startups are associated with biotech. More than 1,100 such biotech startups emerged in the last

year itself," Modi said. The growing demand in the field of biofuels along with expanding R&D infras-

ty for startups and SMEs, he said. "Recently, we have achieved the target of 10% blending of ethanol in petrol. India has also reduced the target of blending 20% ethanol in petrol by 5 years from 2030 to 2025. All these efforts will also create new employment opportunities, create new opportunities for biotech professionals," the PM said.

Hesaid, "There are five big reasons why India is being considered a land of opportunities in the field of biotech. First, diverse population and diverse climatic zones; second, India's talented human capital pool; third, increasing efforts for ease of doing business; fourth, demand for bioproducts is increasing continuously in India; and fifth, India's biotech sector and its track record of success".

The environment ministry issued a detailed rebuttal that cited 11 reasons explaining why the country does not accept its analysis. "The weight of indicators in which the country was performing well has been reduced and reasons for change has not been explained in the report," said
