**GENERAL POWER OF ATTORNEY**

1. To receive from ICICI Bank Limited (“ICICI Bank”, which expression shall, unless it be repugnant to the subject or context thereof, include its successors and assigns) and / or its duly constituted trustees, effective release / reconveyance of properties mortgaged by the Grantor in favour of ICICI Bank and / or its duly constituted trustees, as security for the facilities availed by the Grantor from ICICI Bank, in a form and manner acceptable to ICICI Bank.
2. For the purpose of receiving effective release / reconveyance of the aforementioned properties, to pay all fees, sign documents, furnish details and information, give any statement, letter, clarification or any other writing required or considered necessary by ICICI Bank and / or its duly constitutes trustees, to pay stamp duty on documents if any, present such security documents for registration before appropriate Registrar/Sub-Registrar of Assurances, give authority letters to the Registrar/Sub-Registrar as when required and do such other things and deeds as may be necessary in relation thereto.

3. To furnish such indemnities as may be required by ICICI Bank and / or its duly constituted trustees in relation to effective release / reconveyance of properties mortgaged by the Grantor in favour of ICICI Bank and / or its duly constituted trustees, as security for the facilities availed by the Grantor from ICICI Bank.
4. To enter into / execute and furnish such documents and writings as may be required by the trustees / agents of ICICI Bank.
5. To abide by the provisions of all applicable laws (including the Foreign Exchange Management Act, 1999) in connection with the Facilities availed by the Grantor, from ICICI Bank (including creation and release of security as may be required by ICICI Bank and or its duly constituted trustees).
6. Generally to do all such acts, deeds, matters and things all at my cost and expense as are necessary and incidental to giving security to and receiving effective release / reconveyance of the security, as my Attorney deems fit and proper.

AND I declare, agree and confirm that all or any of the aforesaid powers may be exercised by the Attorney on my behalf.

AND I agree to ratify all lawful acts, deeds, matters, and things done by my Attorney pursuant to the powers hereinbefore mentioned.

This Power of Attorney shall automatically stand revoked on the death, permanent disability, retirement or resignation of the said Attorney.
